



PUBLIC SERVICE ANNOUNCEMENT

The City of Center has received a Community Development Block Grant - Mitigation (CDBG-DR) contract under the Texas General Land Office (GLO) Resilient Communities Program. The City will comply with the Civil Rights requirements of Title I of the Housing and Community Development Act and the Fair Housing Law and ensure that equal opportunities are afforded to all persons and that no person shall be excluded or denied program benefits on the basis of race, color, religion, sex, disability, familial status, and national origin. POLICY OF NONDISCRIMINATION ON THE BASIS OF DISABILITY

CITIZEN PARTICIPATION & GRIEVANCE PROCEDURES NOTICE

The City of Center has adopted complaint and grievance procedures regarding its Texas General Land Office Community Development Block Grant Programs (GLO-CDBG). Citizens may obtain a copy of these written procedures at City Hall, 617 Tenaha Street, Center, Texas 75935, between the hours of 8:00 a.m. and 5:00 p.m. Monday through Friday. Citizens may also request the procedures be mailed to them by calling Chad Nehring, City Manager, at 936-598-2941. These procedures outline the steps for a citizen to follow if s/he wishes to file a complaint or grievance about CDBG activities. A person who has a complaint or grievance about any services or activities with respect to the CDBG project, may during regular business hours submit such complaint or grievance, in writing to the City Manager, at 617 Tenaha St., Center, Texas 75935 or may call 936-598-2941. The City of Center will make every effort to respond fully to such complaints within fifteen (15) working days where practicable.

PUBLIC SERVICE ANNOUNCEMENT: FAIR HOUSING, IT'S THE LAW

To promote fair housing practices, the City of Center encourages potential homeowners and renters to be aware of their rights under the National Fair Housing Law. Title VIII of the Civil Rights Act of 1968, as amended, prohibits discrimination against any person on the basis of race, color, religion, sex, disability, familial status or national origin in the sale or rental of units in the housing market.
